As a component of the National Criminal Justice Reference Service (NCJRS), OVCRC has direct access to the most comprehensive criminal justice library in the world—the NCJRS Research and Information Center. The NCJRS collection contains the latest research findings, statistical reports, program descriptions, and evaluations on victim issues published by public and private sources, including the Federal Government. OVCRC acquires more than 500 new documents for the NCJRS collection each year, covering such topics as:

In addition to these resources, OVCRC has developed a vast network of agencies, organizations, and individuals who serve the needs of crime victims. Through this network, OVCRC information specialists will direct you to resources that can address your concerns, such as a victim/witness coordinator in a local prosecutor's office, an expert studying the psychological effects of victimization, or a grass-roots organization involved in protecting victims of domestic violence.

## VICTIM INFORMATION ONLINE

Information concerning crime victims is now available from OVCRC 24 hours a day through the Internet and Fax-on-Demand. The NCJRS World Wide Web Justice Information Center (JIC) menus provide information and publications from all Office of Justice Programs (OJP) agencies—the Office for Victims of Crime, National Institute of Justice, Office of Juvenile Justice and Delinquency Prevention, Bureau of Justice Statistics, and Bureau of Justice Assistance—as well as from the Office of National Drug Control Policy (ONDCP). Many of these publications are available in a format that allows you to download full text and graphics. Announcements about current publications and developments in criminal justice also are published in the free Justice Information (JUSTINFO) Electronic Newsletter distributed on the 1st and 15th of every month. ## **OVCRC PRODUCTS WORKING FOR YOU**

Whether you are a crime victim, a victim advocate, a law enforcement officer, a legislator, a student, or a member of the general public, you can depend on OVCRC's publications and products.

### **PUBLICATIONS**

OVCRC distributes victim-related publications produced by Office of Justice Programs agencies and the Office of National Drug Control Policy. Most of these publications are free. These include OVC documents, Bureau of Justice Statistics data reports, National Institute of Justice research publications, Bureau of Justice Assistance program descriptions and evaluations, Office of Juvenile Justice and Delinquency Prevention bulletins, and Office of National Drug Control Policy drug-related crime fact sheets.

### **OVCRC DATA BASE SEARCHES**

OVCRC provides three data base search products from the NCJRS document collection for a nominal fee.

- Topical Searches are prepackaged document summaries that offer a representative sample of key materials on victims and other criminal justice issues.
- Topical Bibliographies list up to 200 document citations with abstracts, including subject and title indexes, and are more comprehensive than Topical Searches.

- Custom Searches identify citations corresponding to user-specified areas of interest and other parameters. They contain up to 400 citations and include bibliographic information and content summaries. Custom Searches are available in hard copy printouts or on IBM-PC compatible diskettes.

### **SPECIALIZED PRODUCTS**

- Information Packages containing data and research summaries on specific victim issues, relevant OJP documents, a reading list, and contact referrals.
- Fact Sheets summarizing new issues affecting victims and their service providers.
- Videos that can be used as training tools for victim service providers and allied professionals.

### **OVCRC OUTREACH**

In keeping with its primary purpose—to increase awareness of crime victims' needs and to improve services to them—OVCRC maintains a close alliance with victim service professionals. As part of its outreach efforts, OVCRC staff attend national, State, and local conferences and display free literature at the OVCRC exhibit. In addition, OVCRC provides publications and resource materials for training workshops, seminars, and conferences upon request.
